Committee Reports:

Treasurer (Lisa Leana): Santander Checking Balance: \$92,203.82, PayPal Balance: \$3,455.77, Total: \$95,659.51

Recognized show, Summer Opener (Megan Mendenhall, Carol Lippa): Confirmed June 1, 2024. Have a TD - Jennifer Koch and a judge - Kem Barbosa. License has been received.

Membership (Sharon Sexton): 135 have joined for 2024 including 6 juniors.

Quadrille (Anne Miller): No report.

Harvest Fest (Penny Knotts, Darcy Miller): Penny will chair committee. Could use a co-chair.

Eventing (Eliza Herman, Karen Rubin): No report.

Year End Awards (Meg Gioffre): Just Meg is signed up to do awards for 2024 - will need help! Will need help with setup for next year if it's only an hour again. Total spend in 2024 was under the budget.

Sanctioned Schooling Shows (Lisa Leana, Alix James): Everyone from last year signed up. A few still need to pay. They need to have personal/farm membership to be sanctioned shows.

Volunteers (Meg Gioffre): Discussed volunteer time for Board Meetings. Darcy moved and Lisa seconded: In person and online attendance for board meetings will count for volunteer time. Avg meeting time is 1.5 hrs. One hour of volunteer time will be awarded to non-Board club members who attend a board meeting. Board will submit attendance to volunteer coordinator. Side note: Board members receive 16 hours per year for being on board. Must be a member to earn hours.

Region 1 News (Mike): Multiple GMO's presented upcoming events but some were not yet confirmed.

USDF Annual Meeting - Houston, Texas Dec. 4-7. Penny Knotts may attend as Delegate. Confirmed DVCTA stipend to attend is \$750.

L program: Submitted Nov 2-3 2024 Debbie Rodriguez Intro to judging and biomechanics. B session Jan 11-12 2025. Kathy Rowse Judging Cricteria of paces movements and figures. C session March 8-9 2025: Mike Wolzinski Collective marks, rider biomechanics. Lectures at New Bolton Center; Demo rides at Fox Crossing indoor, Walter Rd Cochranville PA Lots of room for Candidates, auditors, volunteers.

<u>Budget</u> – Participants Costs: DVCTA MEMBERS \$950 Part 1 (Sessions A, B & C). NON-DVCTA MEMBERS Auditors (\$100 per session A, B or C). Expenses: Instructors, Lodging, travel, Insurances, Jill Green Cater (B, L, & Snacks). Looking for sponsors for \$500. DVCTA to provide \$1,500. Lots of volunteers needed. Doreen Garland to manage Participants. Need auditor manager. Need demo riders (lots of details). Need volunteer manager. Angie Bean, Kathy King, Carol Lippa, Linda Drejza – need more.

Need to submit application by May/June for Part 2 D1 (classroom 1, NBC April), D2 & Final Exam (When and where?) Need to take to a recognized show that has historically had multiple 2nd level and possible 3rd level: Saugerties, NY, New Jersey Horse Park. Need to talk to show management, chairs, tents, snacks, scoring system (calcs), Participant needs to bring scribes. DO NOT ANNOUNCE until approved by USDF.

Junior Teams (Megan Kuon): No report.

Pub at Dressage at Devon (Mike Broomall): Total check from DAD \$4,951.16 - \$2,120 member fee, \$2,831.16 Pub. We split pub revenue but we still have access to run pub and they pay a member rate. Need to check on when this ends.

Annual Dinner (Lisa Leana): The annual dinner was attended by 95 people. Cost was \$5,200 and tickets covered \$5,000 so very close to break even. Discussed changing format for 2025 to lunch and awards and/or switching to an online auction. Points raised were professionals losing income during the day and possible loss of family attendance. 2025 date is February 8th.

Annual Auction (Linda Drejza, Kelly Barry, Joanne Mohr, Rita Lowry): Linda and Kelly will continue to chair the committee for next year. Financial report to come.
